#### **The European Labour Authority**

The European Labour Authority ('the Authority' or 'ELA') is a Union body in the area of cross-border labour mobility. Its aim is to facilitate access for individuals and employers to information on their rights and obligations; support cooperation between EU countries in the cross-border enforcement of relevant Union law, including by facilitating joint inspections; support Member States in tackling undeclared work and mediate and facilitate a solution in cases of cross-border disputes between national authorities.

The Authority should reach its full operational capacity by 2024. Further information on the Authority is available on its website: [www.ela.europa.eu](http://www.ela.europa.eu).

#### **The job**

The Authority is launching a vacancy notice with a view to establishing a reserve list of Temporary Agents for a position of Senior Labour Mobility Officer in the Enforcement and Analysis Unit.

#### **1. Profile**

Reporting to the Head of Unit for Enforcement and Analysis and to the Head of Sector for Concerted and Joint Inspections, the Senior Labour Mobility Officer for Enforcement and Analysis will contribute to the implementation of the operational tasks of the Authority through the provision of specialised expertise (legal and policy related) on all matters related to the application and enforcement of Union acts within the scope of activities of the Authority<sup>1</sup>, with a particular focus

on concerted and joint inspections<sup>2</sup>, labour mobility analyses and risk assessment<sup>3</sup> and cooperation between Member States in order to tackle undeclared work<sup>4</sup>.

## Tasks

The Senior Labour Mobility Officer's tasks will include, inter alia:

- Providing support to the operational and strategic activities of the Unit and ensuring their alignment with applicable national and EU labour mobility legislation (e.g. directives, regulations and decisions within ELA's mandate);
- Drafting and overall coordination of the Unit's input to ELA single programming document, consolidated annual activity report and risk management strategy;
- Contributing and assisting with the overall design, planning, coordination and delivery of operational and strategic projects and activities performed by the Unit;
- Keeping track of relevant EU legal and policy developments impacting the work of the Unit and of ELA, and, where necessary, disseminating that information to relevant stakeholders;
- Providing expert input, including of a legal nature, to the drafting and reviewing of reports, briefings, papers and other documents related to ELA's operational activities, with a focus on labour mobility and social security;
- Contributing to the development of processes and procedures related to the planning and execution of operational activities delivered by the Unit vis-à-vis ELA founding Regulation, and to any other relevant rules and/or procedures, in relation to, *inter alia*, support provided to concerted and joint inspections;
- Assisting with procurement procedures and management of contracts related to the provision of operational, analytical, logistical, financial and legal support delivered to Member States within the scope of the Unit's operations;
- Fostering and maintaining strong and open cooperation with national authorities, EU institutions and other relevant stakeholders, including social partner organisations, in the field of activities of the Unit;
- Working closely, and when necessary, under the guidance of ELA's Legal Officer, to ensure all legal guidance provided to the Unit's operational activities is sound and in line with ELA's policies;
- Liaising with other Units and Sectors within ELA, including its network of National Liaison Officers, to coordinate horizontal activities and facilitate internal cooperation;
- Representing the Unit in events and/or discussions with internal and external stakeholders, or at any other expert fora, as requested;
- Performing any other related tasks requested by the line management in the interest of the service.

## **Qualifications and experience required**

### **2. Eligibility criteria**

By the closing date for applications to this vacancy notice, candidates must fulfil the requirements below:

#### **2.1. General conditions**

- be a national of a Member State of the European Union;
- enjoy their full rights as citizens<sup>5</sup>;
- have fulfilled any obligations imposed by national laws concerning military service;
- meet the appropriate personal and professional requirements for the duties involved;
- be physically fit to perform their duties<sup>6</sup>;

#### **2.2. Language skills**

Candidates must have a thorough knowledge of one official language of the European Union and a satisfactory knowledge<sup>7</sup> (level B2) of another language of the Union<sup>8</sup>. As the predominant working language of ELA is English, candidates must have an excellent command of spoken and written English<sup>9</sup>.

#### **2.3. Education**

Candidates must have, at the closing date for applications,

- a) a level of education which corresponds to completed university studies of at least three (3) years attested by a diploma<sup>10</sup> and appropriate professional experience of at least one (1) year.

b) a level of education which corresponds to completed university studies of at four (4) years attested by a diploma.

*Candidates must indicate in their applications the official graduation dates for all the diplomas they have obtained.*

## **2.4. Professional Experience**

Candidates must have, at the closing date for applications, professional experience of at least six (6) years<sup>11</sup> (acquired after the education referred to in Section 2.3 Education).

## **3. Selection criteria**

### **Essential:**

- Professional experience of at least five (5) years working relevant to the tasks described above;
- Professional experience in providing legal advice on activities, policies and strategies aimed at tackling fraud and irregularities concerning labour mobility (such as fraudulent posting of workers, use of letter-box entities, bogus self-employment, social fraud, undeclared work) and on others issues relevant to mobile workers' employment conditions, and the good functioning of the EU labour market;
- Professional experience in drafting legal documents, decisions and opinions, in particular with reference to labour mobility and/or rules of procedures for decision-making bodies;
- Expert knowledge of EU legislation in the field of labour mobility, and of relevant CJEU case law;
- University degree in law, labour law, international law or relevant law field.

### **Advantageous:**

- Experience in working in international and/or multicultural environments;
- Professional experience with EU Institutions and/or national administrations in the areas of labour law, labour mobility and coordination of social security systems;
- Experience with cross-border activities aimed at enforcing EU labour mobility and social security rules, directly or in a supportive role;
- Training and/or empirical knowledge and experience with data protection regulations;
- Familiarity with project management.

Moreover, the following competencies will be assessed during the selection process:

- Excellent team working spirit and ability to contribute to a positive working environment
- Excellent oral and written communication skills;
- Excellent interpersonal and negotiation skills to liaise with external contractors and stakeholders;

- Service-oriented attitude;
- Excellent planning and organisational skills.

## **The selection process**

**Before applying, you should carefully check whether you meet all the eligibility criteria.**

Applications must include a motivation letter and a CV, both submitted in English to be considered. **Applications not submitted in English will be excluded from the selection procedure.**

To be able to apply via EU CV Online, you must first create an account or sign in to an existing account. If not done already, you must first fill in the electronic CV. Once the CV is completed, you may choose and apply to the call for expressions of interest of your choice. You are advised to fill out ALL relevant fields of the application. For guidance, please refer to the guidelines for applications to candidates in [ELA's website](#).

Only complete applications registered via EU CV Online before the deadline will be considered. Please note that the selection committee can only take into account the information provided by the candidate via EU CV Online. No information via email will be taken into consideration.

It is your responsibility to complete your online registration in time. We strongly advise you not to wait until the last few days before applying, since heavy internet traffic or a problem with the internet connection could lead to your online registration being interrupted before you complete it, thereby obliging you to repeat the whole process.

After a correct submission of an application, you will receive an automated acknowledgement of receipt of your application to the email account indicated in your application and, you will receive on screen a registration number. If you do not receive a number, it means that your application has not been registered. Please note it is your responsibility to verify that you provided the correct e-mail address.

## **5. Steps of the selection procedure**

### **5.1. Admission to the selection procedure**

After the deadline for online registration, the selection committee will check the submitted applications against the **eligibility criteria** described in Section 2.

The selection committee will analyse if the application was submitted in English. Applications not submitted in English will be excluded from the selection procedure.

Applications satisfying all these conditions will then be initially assessed against the **selection criteria** under Section 3.

### **5.2. Initial assessment of the eligible applications**

The selection committee will assess each eligible application with reference to the selection criteria (“Essential” and “Advantageous”) described in Section 3.

Upon completion of the assessment, the selection committee will establish a shortlist of candidates to be invited to the assessment phase.

Please note that once the pre-assessment phase is completed, shortlisted candidates will be invited to the assessment phase. The remaining candidates will be notified, by email, that their application will no longer be taken into consideration.

### **5.3. The assessment phase**

Following the initial assessment of the applications, shortlisted candidates will be invited to the assessment phase, which will be held online. The assessment phase will be conducted in English.

Details of the date and time of the assessment will be communicated to the shortlisted candidates in due time.

The assessment phase involves an interview with the selection committee and one or more test(s) related to the field of the vacancy. This phase will enable the selection committee to carry out an assessment of the pre-selected candidates according to the selection criteria described in Section 3.

### **5.4. Verification of documents and scrutiny**

If, at any stage in the procedure, it is established that the information in an application has been knowingly falsified or incorrect, the candidate will be disqualified from the selection process.

Candidates will also be disqualified if they:

- do not meet all the eligibility criteria;
- do not provide all the required supporting documents.

Prior to the assessment phase, the shortlisted candidates will be required to provide via email a copy of their documents proving their eligibility, mainly their academic diplomas and evidence of their professional experience clearly indicating the starting and finishing dates, the function(s) and the exact nature of the duties carried out.

Prior to the signature of the contract, the successful candidates must present original versions of documents proving the eligibility criteria and of their experience.

### **5.5. Reserve list**

The selection committee will place the most suitable eligible candidates on a draft reserve list. This draft will be submitted to the Executive Director of ELA for approval. The adopted reserve list will be valid until 31 December 2023. The validity of the reserve list may be extended by decision of the Executive Director of ELA. The information on valid reserve lists of ELA is published on [ELA's website](#).

Prior to being offered a post, candidates on a reserve list may be required to undergo further evaluation by ELA (e.g. including a further interview with the Executive Director).

Candidates should note that the inclusion on the reserve list does not imply any entitlement to employment in ELA.

## **Other important information**

### **6. General information**

#### **6.1. Equal opportunities**

The Authority is an equal opportunity employer and strongly encourages applications from all candidates who fulfil the eligibility criteria and interested in the position. ELA ensures that its recruitment procedures do not discriminate on the grounds of gender, colour, race, ethnic or social origin, genetic features, language, religion or belief, political or any other opinion, membership of a national minority, property, birth, disability, nationality, age, sexual orientation or gender identity.

#### **6.2. Selection committee**

A selection committee is appointed for each selection procedure. The selection committee is composed of at least three (3) members, including a member designated by the Staff Committee.

Please note that the selection committee's internal proceedings are strictly confidential and that any contact with its members is strictly forbidden. Under no circumstances should candidates

approach the selection committee, either directly or indirectly, concerning the selection procedure. Any infringement of this rule will lead to the disqualification from the selection procedure.

### **6.3. Approximate timetable**

The selection process may take some months to be completed. The selection committee intends to finalise the recruitment process for this vacancy by April 2023, with a view for the selected candidate to take office by June 2023.

The foreseen timeframe for the selection procedure will be updated on [ELA's website](#).

Please note that once the pre-assessment phase is completed, shortlisted candidates will be invited to the assessment phase. The remaining candidates will be notified, by email, that their application will no longer be taken into consideration.

### **6.4. Engagement and Conditions of employment**

The decision on appointment will be taken by the Authority's Executive Director as the Authority Empowered to Conclude Contracts of Employment on the basis of the reserve list of most suitable candidates.

Before engaging a temporary agent, the Executive Director will examine whether the candidate has any personal interest such as to impair his/her independence or any other conflict of interest. The candidate will inform the Executive Director, using a specific form of any actual or potential conflict of interest<sup>14</sup>. If necessary, the Executive Director shall take any appropriate measures.

A contract may be offered for temporary agent pursuant to Article 2(f) of the Conditions of Employment of Other Servants of the European Union (CEOS) for an initial period of 5 years, renewable once. After the second period, the contract may be renewed for an indefinite period. The jobholder will be subject to a probationary period of 9 months.

### **6.5. Interagency mobility**

Filling a post by means of mobility between EU agencies in the grade bracket AD6-AD7 is also possible, with a view of attracting temporary staff 2(f) that are currently employed at other EU agencies. ELA is following the procedure for interagency mobility and engagement as outlined in the [European Labour Authority Decision](#) of 03.12.2019 laying down general implementing provisions on the procedure governing the engagement and use of temporary staff under Article 2(f) of the CEOS.

### **6.6. Job environment**

The place of employment is Bratislava, Slovakia. Residence within reasonable distance of ELA's office is required in accordance with the Staff Regulations (Article 20).

The jobholder will work in a multicultural, respectful and appreciative environment, which offers the possibility to shape the work of the authority, where collaboration and open and constructive dialogue is encouraged, while building effective work relations.

Working time is based on a 40-hour working week. ELA offers flexible working arrangements such as teleworking, part-time work, and flexible working hours.

### 6.7. Pay and welfare benefits

The successful candidate who is offered a contract of employment will, on their entry into service, **be placed in step 1 or 2 of grade AD7**, according to the length of their professional experience.

The staff member's remuneration consists of a basic salary and allowances. It is paid in euro **weighed down by the correction coefficient** (in Slovakia the correction coefficient is currently 81,3% compared to Belgium).

The gross basic salary, after correction coefficient is applied, is as follows<sup>15</sup>:

**In addition to the basic salary**, staff **may be** entitled to various **allowances** depending on their particular situation. These may include:

- **Household allowance** (e.g. if you have a dependent child or you are married and your spouse's income is below a defined threshold);
- **Dependent child allowance** (e.g. if you have a child under the age of 18 or between 18 and 26, if in specified training programme);
- **Education allowances** (Pre-school or Education allowance) **or Payment of the education fees applicable to selected educational institutions;**
- **Expatriation allowance** or **foreign residence allowance** (16% of the sum of basic salary and other applicable allowances) or foreign residence allowance (4 %).

The salary is subject to a Community tax deducted at source and is exempt from national tax. The salary package includes contributions to the EU social security and pension schemes. Candidates are invited to familiarise themselves with the employment conditions as stated in the [Staff Regulations of Officials and the Conditions of Employment of Other Servants of the European Union](#).

Under certain circumstances, in particular where the jobholder is obliged to change his/her place of residence in order to take up employment, the Agency may also reimburse some expenses incurred on recruitment, notably removal expenses.

#### **Additional benefits:**

- Annual leave entitlement of two days per calendar month plus additional days for age, grade, 2.5 days' home leave, if applicable, and in addition on average 18 public holidays per year;

- Special leave granted for certain circumstances: e.g. removal, marriage, birth of a child, etc.;
- Various training opportunities;
- Social measures;
- EU Pension scheme (granted after 10 years of service);
- EU Joint Sickness Insurance Scheme (JSIS), accident and occupational disease coverage, unemployment and invalidity allowance and insurance.

### **6.8. Protection of personal data**

Personal data shall be processed exclusively for the purpose of this selection procedure. The purpose of processing the data submitted by candidates is to evaluate applications in view of possible recruitment at ELA.

As the body responsible for organising the competition, the Authority ensures that applicants' personal data are processed as required by Regulation (EU) 2018/1725 of the European Parliament and of the Council of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, offices and agencies and on the free movement of such data (Official Journal of the European Union, L 295/39 of 21 November 2018). The complaint must be lodged within 3 months. The time limit for initiating this type of procedure (see Staff Regulations as modified by Council Regulation No 723/2004 of 22 March 2004 published in the Official Journal of the European Union L 124 of 27 April 2004 – <http://europa.eu/eur-lex>) starts to run from the time the candidate is notified of the act adversely affecting him/her.

Should the complaint be rejected, the candidate may request judicial review of the act adversely affecting him/her pursuant to Article 270 of the Treaty on the Functioning of the European Union and Article 91 of the Staff Regulations, before the General Court:

Please note that complaints made to the Ombudsman have no suspensive effect on the period laid down in Articles 90(2) and 91 of the Staff Regulations for lodging, respectively, a complaint or an appeal with the European Union Civil Service Tribunal under Article 236 of the EC Treaty. Any complaint to the ombudsman must be made within two years of receiving the Authority's final position on the matter.
