#### **The European Labour Authority**

The European Labour Authority ('the Authority' or 'ELA') is a Union body in the area of cross-border labour mobility. Its aim is to facilitate access for individuals and employers to information on their rights and obligations; support cooperation between EU countries in the cross-border enforcement of relevant Union law, including by facilitating concerted and joint inspections (hereinafter Inspections); support Member States in tackling undeclared work and mediate and facilitate a solution in cases of cross-border disputes between national authorities.

The Authority should reach its full operational capacity by 2024. Further information on the Authority is available on its website: [www.ela.europa.eu](http://www.ela.europa.eu).

#### **The job**

The European Labour Authority is launching an information notice with a view to establishing a reserve list of Contract Agents for the position of EURES Data Analysis Officer.

Working in ELA's EURES team, the job holder will contribute to the activities of the European Coordination Office (ECO) of EURES, in line with Article 6 of ELA's founding Regulation and Article 8 of Regulation (EU) 2016/589 on a European network of employment services (EURES).

ELA's management of ECO is divided into two broad strands: the management of the EURES portal and the coordination of and support to EURES' human network. The EURES Data Analysis Officer will be involved in both strands and hence is expected to collaborate with several staff members in the EURES team, as well as with staff members of other teams (such as the Information team or the Labour Market Analysis and Risk Assessment team).

## 1. Profile

Reporting to the Head of Information and EURES unit, the jobholder will play a key role in the EURES activities related to information provision and labour market intelligence.

### MAIN TASKS

The EURES Data Analysis Officer's tasks will include, inter alia:

- Familiarising with the EURES portal data, that is structured information derived from the job vacancies and CVs compiled in the EURES database, such as the architecture of the database and the characteristics of the data collected;
- Building up expertise on the EURES portal data to become the central contact point for any queries related to the data from a statistical point of view;
- Conducting extractions (or requesting them from the EURES portal technical solution provider) of the EURES portal data on a regular basis as well as ad-hoc/on-demand following specific requests from internal and external stakeholders, checking the extractions for data validity and reliability, and compiling the relevant data into a user-friendly presentation format (e.g. tables, graphs) targeting a non-technical audience; this can also include drafting short interpretative narratives or explanatory texts;
- Contributing to the assessment of data quality, the sustainability of the EURES database architecture and to the development of a strategy and implementation of mechanisms to further improve the EURES portal data;
- Developing concepts for enhanced use of EURES portal data for information provision and labour market intelligence purposes, including potential combination with other data sources at national or European level;
- Contributing to reviewing the current methodology of collecting, compiling and presenting the information of the EURES portal section on 'Labour Market Information', that is mainly (a combination of) secondary labour market data from external European and national data sources, and to developing a revised approach to this EURES information tool;
- Depending on the outcome of the review exercise of the Labour Market Information section, contributing to or taking a leading role in managing the regularly recurring data collection, compilation and quality assurance for this information (mainly external European and national data sources);
- Contributing to the development of a statistical approach to identify and characterise labour shortages and surpluses in Europe, with the aim to establish a thematic online data provision tool on the EURES portal which draws on (an integration/combination of) national and European data (potentially including EURES portal data);
- Depending on the statistical model on labour shortages and surpluses, contributing or taking a leading role in managing the regularly recurring data collection, compilation and quality assurance for this information;
- Contributing to other activities related to EURES labour market intelligence provision, such as quantitative/statistical input into strategic foresight/scenario building activities;
- Contributing to ELA's cooperation with external stakeholders (such as the EURES network, the European Commission, Eurostat, EU Agencies, national bodies like National Statistical Offices or Public Employment Services or contractors) related to EURES portal data, information provision and labour market intelligence; this can include contributing to strategic discussions by, for example, preparing background/concept notes, participating in meetings or following up on discussion outcomes;
- Performing any other task requested by the line management in the interest of the service.

## QUALIFICATIONS AND EXPERIENCE REQUIRED

### Qualifications and experience required

#### 2. Eligibility criteria

By the closing date for applications to this vacancy notice, candidates must fulfil the requirements below:

##### 2.1. General conditions

- be a national of a Member State of the European Union;
- enjoy their full rights as citizens<sup>1</sup>;
- have fulfilled any obligations imposed by national laws concerning military service;
- meet the appropriate personal and professional requirements for the duties involved;
- be physically fit to perform their duties<sup>2</sup>.

##### 2.2. Language skills

Candidates must have a thorough knowledge of one official language of the European Union and a satisfactory knowledge<sup>3</sup> (level B2) of another language of the Union<sup>4</sup>. As the predominant working language of ELA is English, candidates must have an excellent command of spoken and written English<sup>5</sup>.

##### 2.3. Education

Candidates must have, at the closing date for applications,

a level of education which corresponds to completed university studies of at least three (3) years attested by a diploma<sup>6</sup>.

<sup>4</sup> Candidates must also have a satisfactory knowledge of another official language of the European Union to the extent necessary for the performance of his/her duties. The European Union has 24 official languages: Bulgarian, Croatian, Czech, Danish, Dutch, English, Estonian, Finnish, French, German, Greek, Hungarian, Irish, Italian, Latvian, Lithuanian, Maltese, Polish, Portuguese, Romanian, Slovak, Slovenian, Spanish and Swedish.

### **3. Selection criteria**

**Candidates will be invited for interviews on the basis of the following criteria:**

**Essential criteria:**

- At least 2 years professional experience in tasks similar to the ones described in the “main tasks” section above;
- Professional experience in data collection, compilation and quality assurance for this information;
- Experience in data analysis and techniques using statistical methods (please indicate which methods).

**Advantageous criteria:**

- Experience working in an international or multicultural environment.

Moreover, the following competencies will be assessed during the selection process:

- Excellent team working spirit and ability to contribute to a positive working environment;
- Excellent oral and written communication skills;
- Service-oriented attitude;
- Excellent planning and organisational skills.

All subsequent communication between ELA and you will be by post. In this case, you must enclose with your application a certificate attesting your disability, issued by a recognised body. You should also set out on a separate sheet of paper any special arrangements you think are needed to make it easier for you to take part in the selection.

To be able to apply via EU CV Online, you must first create an account or sign in to an existing account. If not done already, you must first fill in the electronic CV. Once the CV is completed, you may choose and apply to the call for expressions of interest of your choice. You are advised to fill out ALL relevant fields of the application. Only complete applications registered via EU CV Online before the deadline will be considered. Please note that the selection committee can only take into account the information provided by the candidate via EU CV Online. No information via email will be taken into consideration.

It is your responsibility to complete your online registration in time. We strongly advise you not to wait until the last few days before applying, since heavy internet traffic or a problem with the internet connection could lead to your online registration being interrupted before you complete it, thereby obliging you to repeat the whole process.

After a correct submission of an application, you will receive an automated acknowledgement of receipt of your application to the email account indicated in your application and, you will receive on screen a registration number. If you do not receive a number, it means that your application has not been registered. Please note it is your responsibility to verify that you provided the correct e-mail address.

## **5. Steps of the selection procedure**

### **5.1. Admission to the selection procedure**

After the deadline for online registration, the selection committee will check the submitted applications against the **eligibility criteria** described in Section 2.

The selection committee will analyse if the application was submitted in English. Applications not submitted in English will be excluded from the selection procedure.

Applications satisfying all these conditions will then be initially assessed against the **selection criteria** under Section 3.

### **5.2. Initial assessment of the eligible applications**

The selection committee will assess each eligible application with reference to the selection criteria ("Essential" and "Advantageous") described in Section 3.

Upon completion of the assessment, the selection committee will establish a shortlist of candidates to be invited to the assessment phase.

Please note that once the pre-assessment phase is completed, shortlisted candidates will be invited to the assessment phase. The remaining candidates will be notified, by email, that their application will no longer be taken into consideration.

### **5.3. The assessment phase**

Following the initial assessment of the applications, shortlisted candidates will be invited to the assessment phase, which will be held online. The assessment phase will be conducted in English.

Details of the date and time of the assessment will be communicated to the shortlisted candidates in due time.

The assessment phase involves an interview with the selection committee and one or more test(s) related to the field of the vacancy. This phase will enable the selection committee to carry out an assessment of the pre-selected candidates according to the selection criteria described in Section 3.

### **5.4. Verification of documents and scrutiny**

If, at any stage in the procedure, it is established that the information in an application has been knowingly falsified or incorrect, the candidate will be disqualified from the selection process.

Candidates will also be disqualified if they:

- do not meet all the eligibility criteria;
- do not provide all the required supporting documents.

Prior to the assessment phase, the shortlisted candidates will be required to provide via email a copy of their documents proving their eligibility, mainly their academic diplomas and evidence of their professional experience clearly indicating the starting and finishing dates, the function(s) and the exact nature of the duties carried out.

Prior to the signature of the contract, the successful candidates must present original versions of documents proving the eligibility criteria and of their experience.

### **5.5. Reserve list**

The selection committee will place the most suitable eligible candidates on a draft reserve list. This draft will be submitted to the Executive Director of ELA for approval. The adopted reserve list will be valid until 31 December 2024. The validity of the reserve list may be extended by decision of the Executive Director of ELA. The information on valid reserve lists of ELA is published on [ELA's website](#).

Prior to being offered a post, candidates on a reserve list may be required to undergo further evaluation by ELA (e.g. including a further interview with the Executive Director).

Candidates should note that the inclusion on the reserve list does not imply any entitlement to employment in ELA.

## **Other important information**

### **6. General information**

#### **6.1. Equal opportunities**

The Authority is an equal opportunity employer and strongly encourages applications from all candidates who fulfil the eligibility criteria and interested in the position. ELA ensures that its recruitment procedures do not discriminate on the grounds of gender, colour, race, ethnic or social origin, genetic features, language, religion or belief, political or any other opinion, membership of a national minority, property, birth, disability, nationality, age, sexual orientation or gender identity.

#### **6.2. Selection committee**

A selection committee is appointed for each selection procedure. The selection committee is composed of at least three (3) members, including a member designated by the Staff Committee.

Please note that the selection committee's internal proceedings are strictly confidential and that any contact with its members is strictly forbidden. Under no circumstances should candidates approach the selection committee, either directly or indirectly, concerning the selection procedure. Any infringement of this rule will lead to the disqualification from the selection procedure.

#### **6.3. Approximate timetable**

The selection process may take some months to be completed. The selection committee intends to finalise the recruitment process for this vacancy by September 2023, with a view for the selected candidate to take office by November 2023.

The foreseen timeframe for the selection procedure will be updated on [ELA's website](#).

Please note that once the pre-assessment phase is completed, shortlisted candidates will be invited to the assessment phase. The remaining candidates will be notified, by email, that their application will no longer be taken into consideration.

#### **6.4. Engagement and Conditions of employment**

The decision on appointment will be taken by the Authority's Executive Director as the Authority Empowered to Conclude Contracts of Employment on the basis of the reserve list of most suitable candidates.

Before engaging a contract agent, the Executive Director will examine whether the candidate has any personal interest such as to impair his/her independence or any other conflict of interest. The

candidate will inform the Executive Director, using a specific form of any actual or potential conflict of interest<sup>9</sup>. If necessary, the Executive Director shall take any appropriate measures.

A contract may be offered for contract agent pursuant to Article 3(a) of the Conditions of Employment of Other Servants of the European Union (CEOS) for an initial period of 5 years, renewable once. After the second period, the contract may be renewed for an indefinite period. The jobholder will be subject to a probationary period of 9 months.

## 6.5. JOB ENVIRONMENT

The place of employment is Bratislava, Slovakia.

The jobholder will work in a multicultural, respectful and appreciative environment, which offers the possibility to shape the work of the authority, where open and constructive dialogue is encouraged, while building effective work relations.

Working time is based on a 40-hour working week. ELA offers flexible working arrangements such as teleworking, part-time work, and flexible working hours.

## 6.6. PAY AND WELFARE BENEFITS

The successful candidate who is offered a contract of employment will, on their entry into service, **be placed in grade 13, 14 or 16 of function group IV**, according to the length of their professional experience<sup>10</sup>.

The staff member's remuneration consists of a basic salary and allowances. It is paid in Euro **weighed down by the correction coefficient** (in Slovakia the correction coefficient is currently 80,9% compared to Belgium).

The gross basic salary, after correction coefficient is applied, is as follows<sup>11</sup>:

**In addition to the basic salary**, staff **may be** entitled to various **allowances** depending on their particular situation. These may include:

- **Household allowance** (e.g. if you have a dependent child or you are married and your spouse's income is below a defined threshold);
- **Dependent child allowance** (e.g. if you have a child under the age of 18 or between 18 and 26, if in specified training programme);
- **Education allowances** (Pre-school or Education allowance) **or Payment of the education fees applicable to selected educational institutions;**
- **Expatriation allowance** or **foreign residence allowance** (16% of the sum of basic salary and other applicable allowances) or foreign residence allowance (4%).

The salary is subject to a Community tax deducted at source and is exempt from national tax. The salary package includes contributions to the EU social security and pension schemes.

Candidates are invited to familiarise themselves with the employment conditions as stated in the [Staff Regulations of Officials and the Conditions of Employment of Other Servants of the European Union](#).

Under certain circumstances, in particular where the jobholder is obliged to change his/her place of residence in order to take up employment, the Agency may also reimburse some expenses incurred on recruitment, notably removal expenses.

#### **Additional benefits:**

- Annual leave entitlement of two days per calendar month plus additional days for age, grade, 2.5 days' home leave, if applicable, and in addition on average 18 public holidays per year;

#### **6.7. Protection of personal data**

Personal data shall be processed exclusively for the purpose of this selection procedure. The purpose of processing the data submitted by candidates is to evaluate applications in view of possible recruitment at ELA.

#### **6.9. Appeal procedure**

The complaint must be lodged within 3 months. The time limit for initiating this type of procedure (see Staff Regulations as modified by Council Regulation No 723/2004 of 22 March 2004 published in the Official Journal of the European Union L 124 of 27 April 2004 – <http://europa.eu/eur-lex>) starts to run from the time the candidate is notified of the act adversely affecting him/her.

Should the complaint be rejected, the candidate may request judicial review of the act adversely affecting him/her pursuant to Article 270 of the Treaty on the Functioning of the European Union and Article 91 of the Staff Regulations, before the General Court:

Please note that complaints made to the Ombudsman have no suspensive effect on the period laid down in Articles 90(2) and 91 of the Staff Regulations for lodging, respectively, a complaint or an appeal with the European Union Civil Service Tribunal under Article 236 of the EC Treaty. Any complaint to the ombudsman must be made within two years of receiving the Authority's final position on the matter.
